Criteria Used in Evaluation of pre-selected suppliers:

1. Should have submitted a certification which guarantees its ability to provide technical assistance whenever necessary.
2. Should have passed BSPD laboratory evaluation on stitching thread sample/delivery.
3. Should have submitted an organizational profile of the stitching thread manufacturing company/ principal indicating production capacity, management structure, manufacturing process/equipment, products and other relevant information.
4. Should have submitted ISO Quality Management Certification or its equivalent.
5. Should have submitted ISO Environmental Management Certification or Certification of compliance with environmental standards.
6. Should have submitted local representative's company profile and copy of formal endorsement by the paper manufacturing company.
7. Should have submitted local representative's business permit.
8. Should have submitted copy of Certificate of Registration of the local representative issued by Securities and Exchange Commission (SEC) or Certificate of Business Name Registration issued by the Department of Trade and Industry (DTI) for proprietorship.
9. Should have submitted the latest or not earlier than two (2) years from the current year the Audited Financial Statement (Balance Sheet and Income Statement).
10. Total net worth should be positive.


