

## **BAC RESOLUTION NO. 58-2018**

### **RECOMMENDING AWARD OF CONTRACT FOR THE HIRING OF CONSULTANT FOR THE DEVELOPMENT OF AUDIO-VISUAL PRESENTATIONS, ENHANCEMENT OF E-MODULES, AND DEVELOPMENT AND PRODUCTION OF INFORMATION, EDUCATION, AND COMMUNICATION (IEC) MATERIALS ON GOVERNMENT PROCUREMENT**

**WHEREAS**, on 13 December 2018, Deputy Executive Director Elmira S. Cruz-Caisido, as OIC – Head of the Procuring Entity (HoPE), approved the updated 2018 Annual Procurement Plan (APP) of the Government Procurement Policy Board – Technical Support Office (GPPB-TSO) upon favorable recommendation by its Bids and Awards Committee (BAC);

**WHEREAS**, the APP contains the project entitled *Hiring of Consultant for the Development of Audio-Visual Presentations* with a total Approved Budget for the Contract (ABC) amounting to Two Million Pesos (₱2,000,000.00).

**WHEREAS**, the project which also includes the *Enhancement of E- Modules and Development and Production of Information, Education, and Communication (IEC) Materials on Government Procurement* will be undertaken through Negotiated Procurement (Agency-to-Agency) under Section 53.5 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

**WHEREAS**, the concerned End-User Unit has submitted a justification recommending that Negotiated Procurement (Agency-to-Agency) be resorted to in order to obtain the most advantageous contract for the government.

**WHEREAS**, the End-User Unit recommended to enter into Memorandum of Agreement with the Presidential Communications Operations Office (PCOO);

**WHEREAS**, the PCOO submitted a certificate of its compliance with all the conditions prescribed under Section 53.5 of the 2016 revised IRR of RA No. 9184 and its Annex “H” or the Consolidated Guidelines for the Alternative Methods of Procurement;

**WHEREAS**, the justification and assessment and recommendation to resort to Agency-to-Agency from the End-User Unit, and the Certificate of Compliance from the Servicing Agency are attached, and made integral parts hereof;

**NOW, THEREFORE, WE**, the Members of the **BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on **Us** by law, hereby resolve to recommend to the Head of the Procuring Entity for Her consideration and approval to enter into a Memorandum of Agreement (MOA) with the Presidential Communications Operations Office for the *Hiring of Consultant for the Development of Audio-Visual Presentations, Enhancement of E- Modules, and Development and Production of Information, Education, and*

Communication (IEC) Materials on Government Procurement in accordance with Negotiated Procurement (Agency-to-Agency) under Section 53.5 of the 2016 revised IRR of RA No. 9184.

This resolution shall take effect immediately.
