

BAC RESOLUTION NO. 03 - 2018

Recommending Award for the Postal and/or Mailing Services of various Reply Letters (RLs) of the Performance Monitoring Division (PMD) under Consolidated Guidelines for the Alternative Methods of Procurement under Section 53.5 (Agency-to-Agency) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184

WHEREAS, on 10 January 2018, Executive Director Dennis S. Santiago, Head of Procuring Entity (HoPE), approved the 2018 Annual Procurement Plan (APP) of the Government Procurement Policy Board – Technical Support Office (GPPB-TSO) upon favorable recommendation of its Bids and Awards Committee (BAC);

WHEREAS, the 2018 APP includes the item entitled as “*Postage and Deliveries*” to be undertaken through Section 53.5 (Agency-to-Agency) of the 2016 IRR of RA No. 9184 with a budget amounting to *Two Hundred Seventy Thousand Pesos (PhP 270,000.00)* under the GPPB-TSO Fund;

WHEREAS, the Administrative and Finance Division (AFD) and Performance Monitoring Division (PMD), intend to engage the services of the Philippine Postal Corporation (PHLPOST), a government owned and controlled corporation (GOCC), mandated in the shipment and delivery of mail matters and logistics locally and abroad, from January 2018 to December 2018;

WHEREAS, as a requirement under Section 53.5 (Agency-to-Agency) of the 2016 IRR of RA No. 9184, a Cost-Benefit Analysis (CBA) was undertaken to verify that engaging the services of PHLPOST will be the most advantageous contract for the government;

WHEREAS, the CBA contains price quotations from three (3) private postal and mailing service companies (*i.e. LBC, 2Go Delivery, and JRS Express*) and PHLPOST;

WHEREAS, the quotations obtained from the private postal and mailing service companies and PHLPOST are based on their respective rates. A summary of the quotations submitted are as follows:

WHEREAS, the concerned End-User Units recommended that Negotiated Procurement (Agency-to-Agency) with PHLPOST under Section 53.5 of the IRR of RA No. 9184 be resorted to in order to obtain the most advantageous contract for the government;

WHEREAS, PHLPOST submitted a certificate of its compliance with all the conditions prescribed under Section 5 (a) and (b) of the Implementing Guidelines on Agency-to-Agency Agreements in relation to Section 53.5 of the IRR of RA No. 9184;

WHEREAS, the CBA and the Certificate of Compliance are attached, and made integral parts hereof;

NOW, THEREFORE, WE, the Members of the **BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on Us by law, hereby resolve to enter into a Memorandum of Agreement (MOA) with the **Philippine Postal Corporation (PHLPOST)** for the *Postage and Deliveries* in the amount of *Two Hundred Seventy Thousand Pesos (PhP 270,000.00)* pursuant with the provisions of Negotiated Procurement (Agency-to-Agency) under Section 53.5 of the 2016 IRR of RA No. 9184.

This resolution shall take effect immediately.
