

BAC RESOLUTION NO.50-2017

RECOMMENDING AWARD OF CONTRACT FOR THE PUBLICATION OF THE SECOND EDITION OF VOLUMES I, II, III and IV OF THE GENERIC PROCUREMENT MANUALS

WHEREAS, on 12 December 2017, Deputy Executive Director (DED) Melissa A. Santiago-Yan, as OIC – Head of the Procuring Entity (HOPE), approved the twelfth (12th) update of the 2017 Annual Procurement Plan (APP) of the Government Procurement Policy Board – Technical Support Office (GPPB-TSO) upon favorable recommendation of the Bids and Awards Committee (BAC) of the GPPB-TSO;

WHEREAS, the APP contains the project entitled *Publication of GPPB Resolutions, Circulars, and other Issuances* with a total Approved Budget for the Contract (ABC) amounting to Seven Hundred Seventy Nine Thousand Three Hundred Sixty Eight Pesos (₱779,368.00);

WHEREAS, the project includes the procurement for the Publication of the Second (2nd) Edition of the Volumes One through Four (I-IV) of the Generic Procurement Manual (GPM) through Negotiated Procurement (Agency-to-Agency) under Section 53.5 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, with an ABC of Six Hundred Six Thousand (₱606,000.00);

WHEREAS, the concerned End-User Unit has undertaken a Cost-Benefit Analysis (CBA) to determine the most advantageous contract for the government;

WHEREAS, the CBA contains price quotations from three (3) private publishers (*i.e. The Manila Bulletin, Philippine Daily Inquirer, and Business World*) and the National Printing Office (NPO), a recognized government printer with the sole jurisdiction to publish in the Official Gazette;

WHEREAS, the quotations obtained from the private publishers are based on a single broadsheet page. Also, it is estimated that the publication of the 5th Edition of the *Philippine Bidding Documents* will consume more than two (2) full pages. A summary of the quotations submitted are as follows:

WHEREAS, the quotation obtained from the NPO amounted to only **Five Hundred Ninety Thousand Seven Hundred Sixty Eight Pesos and ⁹⁷/₁₀₀ (P590,768.97)**, which is inclusive of publication in the Official Gazette and one hundred (100) books/copies thereof;

WHEREAS, the concerned End-User Unit recommended that Negotiated Procurement (Agency-to-Agency) under Section 53.5 of the 2016 revised IRR of RA 9184 be resorted to in order to obtain the most advantageous contract for the government;


WHEREAS, the NPO submitted a certificate of its compliance with all the conditions prescribed under Annex H of the 2016 Revised IRR;

WHEREAS, the CBA, the Certificate of Compliance from the Servicing Agency and the Assessment and Recommendation of the End-User unit are attached, and made integral parts hereof;


NOW, THEREFORE, WE, the Members of the **BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on US by law, hereby resolve to enter into a Memorandum of Agreement (MOA) with the National Printing Office for the *Publication of the 2nd Edition of Volumes I, II, III, and IV of the Generic Procurement Manual* in accordance with Negotiated Procurement (Agency-to-Agency) under Section 53.5 of the 2016 Revised IRR of RA 9184.

This resolution shall take effect immediately.

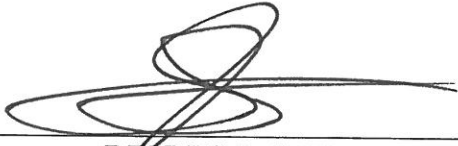
