

CONTRACT OF SERVICES

KNOW ALL MEN BY THESE PRESENTS:

This contract made and executed by and between:

Government Procurement Policy Board Technical Support Office (GPPB-TSO) with office address at Unit 2506 Raffles Corporate Center, F. Ortigas Jr. Ortigas Center, Pasig City, represented herein by its Deputy Executive Director, **Atty. Elmira S. Cruz-Caisido** hereinafter referred to as the **FIRST PARTY**. **PRINCE PLAZA HOTEL**, a duly organized company existing under and by virtue of the laws of the Republic of the Philippines, with business address at #17 Legarda Road, Baguio City represented in this agreement by its Hotel Supervisor, **Rod G. Manangan** hereinafter referred to as the **SECOND PARTY**.

-WITNESSETH-

WHEREAS, the **FIRST PARTY** is desires to conduct a three (3) day seminar and/or conference on May 3-5, 2017 at PRINCE PLAZA HOTEL.

WHEREAS, the **SECOND PARTY** accepts the reservation for the **FIRST PARTY** and will provide the catering service under the following terms and conditions:

1. That the **SECOND PARTY** will serve 1 meal or lunch and 2 snacks (am & pm snack) to be served at 12:00 noon, 10:00am and 3:00pm respectively for 75 - 106 attendees on May 3-5, 2017 at the rate of Six Hundred Fifty Pesos (Php 650.00) per person a day. In excess of the minimum, the **FIRST PARTY** will pay the **SECOND PARTY** at the rate of Six Hundred Fifty Pesos (Php 650.00);
2. That the **SECOND PARTY** shall provide room accommodation consisting of 2 - 3 rooms, Twin Sharing at the rate of Two Thousand Five Hundred Pesos (Php 2,500.00) per room for Three (3) nights;
3. The **SECOND PARTY** shall bill the **FIRST PARTY** based on the actual number of attendees and actual number of rooms occupied. The **FIRST PARTY** will pay the **SECOND PARTY** within 30 days after the submission of the billing statement.

Amount of contract based on maximum range:

Participants: 106 guaranteed pax

P650.00/pax for three (3) days = **Php 206,700.00**

Room Accommodation (inclusive of breakfast)

Three (3) rooms (Twin Sharing) at the rate of Php 2,500.00/night for Three (3) nights
= **Php 22,500.00**



Plate Dinner for Six (6) persons at the rate of Php 300.00 for three (3) nights
= **Php 5,400.00**

Total Contract Amount = Php 234,600.00

4. That the parties agree that all the agreements contained herein are essential conditions to the contract. Subject to Clause 1 of this Contract, in case of breach by the **SECOND PARTY**, the **FIRST PARTY** Shall have the option to cancel and/or effect changes the above-mentioned terms and conditions or the contract out another caterer at no additional cost to the **FIRST PARTY** and demand reimbursement of whatever amount the **FIRST PARTY** paid under Clause 2 of this contract. Both parties shall have the right to terminate the contract, judicially or extra-judicially after demand without prejudice to the right of the prejudiced party to sue for damages in proper court.

5. **FORCE MAJEURE.** Either **PARTY** shall not be held liable for any failure and/or delay in the performance under this Agreement if such failure or delay is due to cause/s beyond its reasonable control, including but not limited to acts of God, war, strikes or labor disputes, embargoes, government orders or any other force majeure event.
