INVITATION TO BID

1. The Government Procurement Policy Board-Technical Support Office (GPPB-TSO), through the authorized appropriations under the FY 2018 General Appropriations Act, intends to apply the sum of Two Million One Hundred Thousand Pesos (PhP2,100,000.00) being the Approved Budget for Contract (ABC) to payments under the contract for the Project, “Supply and Delivery of One (1) Unit Passenger Van”, described below. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Supply and Delivery of One (1) Unit Passenger Van, 2400 to 3000 cc, Diesel, 12 to 13-seater, with standard free items, as per GPPB-TSO Technical Specifications	PhP 2,100,000.00 (Bids exceeding this amount shall be automatically rejected at bid opening.)

2. The GPPB-TSO now invites bids for the Project, “Supply and Delivery of One (1) Unit Passenger Van”. Delivery of the Goods shall be in accordance with the Delivery Schedule under Section VI. Schedule of Requirements. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Interested bidders may obtain further information from the GPPB-TSO-Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below during office hours from 9:00 a.m. to 4:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below, free of charge.

It may also be downloaded free of charge from the websites of the Philippine Government Electronic Procurement System (www.philgeps.gov.ph) and the GPPB (www.gppb.gov.ph).

6. The GPPB-TSO will hold a Pre-Bid Conference on October 26, 2018, 3:30 p.m., at Unit 2506, 25th floor, GPPB-TSO Office, Raffles Corporate Center, F. Ortigas Jr. Road, Ortigas Center, Pasig City, which shall be open to prospective bidders. To ensure completeness and compliance of bids, bidders are advised to send not more than two (2) technical and/or administrative representatives who will prepare the bidding documents.
7. Bids must be duly received by the BAC Secretariat at the address above-mentioned on or before November 7, 2018 at 2:00 p.m. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on November 7, 2018 at 2:30 p.m., at the address above-mentioned. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The GPPB-TSO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA No. 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders. It also assumes no responsibility whatsoever to compensate or indemnify any bidder for expenses incurred in the preparation of bid.
