

ISSUANCE OF THE CONSOLIDATED BLACKLISTING REPORT AND GPPB CIRCULAR NO. 01-2013

WHEREAS, Republic Act (RA) No. 9184, entitled "An Act Providing for the Modernization, Standardization and Regulation of the Procurement Activities of the Government and For Other Purposes," took effect on 26 January 2003, while its revised Implementing Rules and Regulations (IRR) took effect on 2 September 2009;

WHEREAS, the Government Procurement Policy Board (GPPB), under Section 63 of RA 9184 and its IRR, is mandated to formulate and amend public procurement policies, rules and regulations, and amend the IRR, whenever necessary;

WHEREAS, the GPPB issued the Uniform Guidelines for Blacklisting of Manufacturers, Suppliers, Distributors, Contractors and Consultants (Guidelines), through GPPB Resolution No. 09-2004 dated 20 August 2004, and published in the Official Gazette on 30 November 2004;

WHEREAS, Section 9.2 of the Guidelines, prescribes that the GPPB shall prepare the Consolidated Blacklisting Report every quarter, based on the submitted Blacklisting Orders as provided for in Section 9.1(a) and disseminate the same to procuring entities and the Commission on Audit ("COA");

WHEREAS, Blacklisting Orders received by the Government Procurement Policy Board - Technical Support Office (GPPB-TSO) from procuring entities are posted in the GPPB website for the information of all concerned pending the issuance of a Consolidated Blacklisting Report;

WHEREAS, in its 1st GPPB and Inter-Agency Technical Working Group (IATWG) joint meeting held on 21 January 2013, the GPPB and the IATWG deliberated and resolved to issue the Consolidated Blacklisting Report on a quarterly basis and issue GPPB Circular No. 01-2013, reminding Procuring Entities to submit their Blacklisting Orders to the GPPB-TSO for inclusion in the Consolidated Blacklisting Report. A copy of the Consolidated Blacklisting Report is attached hereto as Annex "A" and made integral part hereof;

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the Members of the **GOVERNMENT PROCUREMENT POLICY BOARD**, by virtue of the powers vested on **US** by law, hereby **RESOLVE** to confirm, adopt, and approve, as **WE** hereby confirm, adopt, and approve the issuance of the Consolidated Blacklisting Report and the issuance of GPPB Circular No. 01-2013.

This resolution shall take effect immediately.
