## **FISCAL YEAR (FY) 2022 PROCUREMENT FORUM:**

In pursuit of its mandate to establish a sustainable training program in order to develop the capacity of government procurement practitioners through the conduct of regular procurement training programs, the Government Procurement Policy Board (GPPB) through its Technical Support Office (TSO) shall organize and hold the "FY 2022 Procurement Forum: Strategic Procurement Management through the use of Digital Technology and Adoption of Sustainability Measures: Electronic Government Procurement and Green Public Procurement in the Philippines" through the Zoom Webinar platform.

Successful registrants who were able to get in the cut-off and secured a slot shall receive a confirmation e-mail together with the activity credentials and other important reminders.

Certificate of Completion shall be issued to participants who will be able to attend and comply with all the requirements while participants with incomplete attendance and requirements shall be issued a Certificate of Participation. No certificate shall be issued to participants who have attended but failed to comply with any of the requirements and to participants who have complied with all the requirements but failed to attend any of the sessions.
