

TRAINING ANNOUNCEMENT

In pursuit of its mandate to establish a sustainable training program in order to develop the capacity of government procurement practitioners through the conduct of regular procurement training programs, the Government Procurement Policy Board (GPPB) through its Technical Support Office (TSO) shall conduct the ***Digital Learning Series (DLS) on Government Procurement through the ZOOM platform*** for the Procurement Practitioners from the Government Sector.

The learning series was launched last October 2020 with two (2) full runs of the Basic Level which aims to capacitate government procurement practitioners on the rules and procedures covered under Republic Act No. 9184 and its 2016 revised Implementing Rules and Regulations and updates thereto, as well as other relevant rules and topics.

For 2021, The GPPB-TSO shall conduct the third run of the DLS Basic Level on **22-26 November, 01-03 and 06-07 December 2021**. Registration fee for each half-day module session shall be **PhP800.00 per participant**.
