Re: Certification Claiming Domestic Preference as Additional Eligibility
Document

Dear Director Paquero:

This is in response to your letter dated 29 August 2013, seeking approval from the Government Procurement Policy Board (GPPB) to allow the inclusion of a Certificate of Domestic Preference issued by the Department of Trade and Industry (DTI), Securities and Exchange Commission (SEC), or Cooperative Development Authority (CDA) in favor of a bidder claiming domestic preference as an additional eligibility requirement.

It is represented that NFA-CARAGA is about to commence the procurement of sacks of palay through public bidding, in line with its mandate to stabilize the price and supply of rice and palay in the CARAGA Region. Prior survey conducted by the Bids and Awards Committee (BAC) of NFA-CARAGA revealed that there are many prospective suppliers of sacks who source their goods from foreign manufacturers. Thus, NFA-CARAGA decided to allow the participation of foreign bidders in accordance with Instructions to Bidders (ITB) Clause 5.2 (c)¹ of the 4th Edition Philippine Bidding Documents (PBDs) for the Procurement of Goods.² This prompted NFA-CARAGA to require the application of the ITB Clauses 27.2 and 27.3 of the PBDs for the Procurement of Goods on Domestic Preference, specifically requiring the domestic bidder or entity to submit a Certificate from the DTI, SEC or CDA, as the case may be, when claiming domestic preference.

As previously opined³ by this office, Procuring Entities (PEs) are proscribed from requiring additional eligibility requirements. This is because the list of minimum eligibility requirements under the revised Implementing Rules and Regulations (IRR) of Republic Act

(RA) No. 9184 have been streamlined such that only those eligibility requirements⁴ enumerated under the revised IRR of RA 9184 are necessary for the purpose of determining the bidders' eligibility. Such eligibility documents are to be included in the First Envelope of the bidder's bid, thereby forming part of the Technical Bid Envelope.⁵ A Certificate issued by the DTI, SEC or CDA supporting the claim by the entity or bidder that it could claim domestic preference is not among the eligibility requirements enumerated in the IRR. Stated otherwise, PEs cannot require a bidder to submit a Certificate claiming domestic preference as this is not an eligibility requirement and not among those expressly required and enumerated by the IRR.

Although Certification issued by the DTI, SEC, or CDA supporting the claim of domestic preference is not an eligibility requirement, it forms part of the Financial Component of the bid which the bidder should include in the Second Envelope in accordance with ITB Clause 13(b)⁶ of the PBDs for the Procurement of Goods. As such, if a bidder wishes to claim domestic preference, it should include said Certification as among the documents in the Second Envelope, forming part of the Financial Component of the bid. This is in accordance with ITB Clauses 27.2⁷ and 27.3⁸ which provide that the Bidder may be granted preference either as a Domestic Bidder⁹ or Domestic Entity¹⁰ subject to the submission by the Domestic Bidder or Domestic Entity of a DTI, SEC or CDA Certification, as the case may be, claiming domestic preference. Corollarily, a bidder waives its right to claim preference as a Domestic Bidder or Domestic Entity if it does not include said Certification as among the documents to be included in the Second Envelope comprising the Financial Component of the bid.

In sum, we wish to clarify that a Certification by the bidder claiming preference as a Domestic Entity or Domestic Bidder cannot be required as an additional eligibility document as this is not among the eligibility documents enumerated under the IRR of RA 9184. Such Certification, however, is submitted as part of the Second Envelope (Financial Bid Envelope) if a bidder intends to claim preference as a Domestic Entity or Domestic Bidder.

We hope that our advice provided sufficient guidance on the matter. Note that this opinion is being issued on the basis of facts and particular situations presented, and may not
