Re: Single Largest Completed Contract

Dear Administrator Maranan:

This is in response to the Honorable Administrator's letter requesting the Government Procurement Policy Board (GPPB) to allow a consortium of Construction Firms duly authorized by a Special Philippine Contractors Accreditation Board (PCAB) License to participate in the procurement of locally-funded Infrastructure Projects with project cost of One (1) Billion Pesos and above through the issuance of a GPPB Resolution. This request is being made relative to the requirement of a Single Largest Completed Contract (SLCC) under Section 23.5.2.5 of the revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

The Honorable Administrator raised the concern that local contractors may not be able to qualify singly on the required experience of having completed at least one (1) contract that is similar to the contract to be bid and whose value must be at least equal to fifty percent (50%) of the Approved Budget Contract (ABC) to be bid, where the ABC is One (1) Billion Pesos and above.

We recognize the Honorable Administrator's concern. However, RA 9184 and its IRR provide for recourse should an interested bidder does not possess the minimum requirements set by the rules. Section 23.5.1.1(e) of the IRR of RA 9184 allows the participation of persons/entities forming themselves into a joint venture, *i.e.*, a group of two (2) or more persons/entities that intend to be jointly and severally responsible or liable for a particular contract. Under this provision, bidders who lack qualifications may enter into a joint venture with other persons or entities possessing the requirements provided by law.

In view of the foregoing, the issue can be addressed by measures sanctioned by RA 9184 and its associated rules. As such, local contractors may still comply with the SLCC by forming a joint venture with other capable contractors, without necessarily having a GPPB issuance allowing a consortium of construction firms to participate in government procurement for infrastructure projects with an ABC of One (1) Billion Pesos and above.


