Re: Conduct of Bidding Prior to Approval of Budget for the Contract

Dear Atty. Berciles:

This refers to your letter dated August 3, 2004, which we received through facsimile on August 4, 2004, requesting clarification on Section 21 of the Implementing Rules and Regulations Part A ("IRR-A") of Republic Act 9184 ("R.A. 9184").

As per your letter, PICC expresses its intent to bid out its annual general services contracts prior to its expiration; however, the annual budget for the succeeding year has not yet been approved by its Board of Directors. The requirement under Section 21 of the IRR-A that the approved budget for the contract shall be included in the Invitation to Apply for Eligibility and to Bid ("IAEB") leads us to the sole substantive issue, to wit:

Whether or not budget estimates may be included in IAEBs instead of the approved budget for the contract in case the appropriate authority has not yet approved the budget for the contract to be bid.

## Approved Budget for the Contract Necessary Prior to Posting

Section 21.1 of the IRR-A of R.A. 9184, provides that "[t]he approved budget for the contract to be bid" shall be included in the IAEB for the information of prospective bidders.

The term "approved budget for the contract" as defined under Section 5(b) of the IRR-A of R.A. 9184 refers to the budget for the contract duly approved by the head of the procuring entity in

the case of national government agencies, by the governing board in the case of government-owned and/or -controlled corporations and state universities and colleges, and by the Sanggunian in the case of local government units.

Accordingly, the amount of the budget for the contract to be included in the IAEB ought to be that which has been duly approved by the appropriate authority, not mere budget estimates. Furthermore, Section 20.1 of the IRR-A provides that during the pre-procurement conference the readiness of the procurement, which includes a determination of the availability of appropriations and programmed budget for the contract at hand, shall be determined before proceeding with the procurement activity.


In fine, a procuring entity cannot replace the requirement for the information on the approved budget for the contract with mere budget estimates. Corollarily, only upon approval by the appropriate authority of the budget for the contract may a procuring entity commence with its procurement activity. As such, PICC cannot use budget estimates as replacement for the approved budget for the contract in the IAEB. It must first secure the approval of its Board of Directors of its annual budget for the succeeding year in order to proceed with the procurement of its general services contracts.

We trust that this clarifies matters.
