Re: Procurement Short of Award

Dear Ms. Dela Cruz:

This refers to your electronic mail inquiring on the applicable procurement rules or issuances relative to the conduct of procurement short of award.

As represented, the MARINA has been encountering delay in the delivery of its Seafarer's Identification and Record Book (SIRB) from its recent procurement. Due to this, two of the three Recognized Government Printers (RGPs) recommended to the MARINA to conduct its 2016 procurement of SIRB in advance using the 2016 National Expenditure Program (NEP) budget levels as basis for its Approved Budget for the Contract (ABC). The two RGPs said that by conducting procurement short of award, they can comply with the delivery requirement as early as the first quarter of 2016.

We wish to clarify that as a general rule, all procurement shall be within the approved budget of the Procuring Entity.¹ Accordingly, the ABC reflected in the approved Annual Procurement Plan (APP) shall be at all times consistent with the appropriations for the project authorized in the General Appropriations Act (GAA), continuing, and automatic appropriations, the corporate budget, or the appropriations ordinance, as the case may be.² By way of exception, however, to facilitate the immediate implementation of projects even pending approval of the GAA, the ABC shall be based on the budget levels under the proposed national budget submitted by the President to Congress.³

For guidance, the Government Procurement Policy Board (GPPB) issued Circular No. 01-2009⁴ providing "*Guidelines Clarifying the Procurement Activities which may be Undertaken Without an Issued Allotment.*" Likewise, the Department of Budget and Management (DBM) issued Circular Letter No. 2010-9⁵ entitled "*Guidelines Directing*
