Re: Negotiated Procurement under Section 53 (b)

Dear Sir:

We respond to your letter dated 5 September 2008 requesting for a clarificatory opinion on whether the Department of Finance (DOF) can directly negotiate with Meralco Industrial Engineering Services Corporation for the supply and installation of a new power service on the basis of Sections 53 (b) of Republic Act (R.A.) No. 9184 and its Implementing Rules and Regulations Part A (IRR-A).

We understand that the DOF is currently experiencing an electric power shutdown resulting from the breakdown of its transformer. Consequently, all offices housed in the DOF building had to be temporarily relocated, including the office of Secretary Margarito B. Teves. As a result, delivery of service is severely hampered and employee's productivity adversely affected.

In accordance with Section 10 of R. A. No. 9184, the procuring entity shall, as a general rule, adopt public bidding as a mode of procurement. However, in order to promote efficiency and economy, the procuring entity may resort to any alternative mode of procurement, subject to the approval of the head of the procuring entity, whenever justified by the conditions provided therein (Section 48, R. A. No. 9184). For instance, under Section 53 (b) of the IRR-A, negotiated procurement may be resorted to in order to immediately restore vital public services, to wit:

"Section 53. Negotiated Procurement

Negotiated Procurement is a method of procurement of goods, infrastructure projects and consulting services, whereby the procuring entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant only in the following cases:

XXX.

b) In case of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities. $x \times x$."

Please be advised that under Section 12 of R. A. 9184, it is the Bids and Awards Committee (BAC) which shall recommend to the head of the procuring entity the use of any of the alternative methods of procurement. Consequently, the determination and accountability for the use of any of the alternative methods rest with the BAC and the head of the procuring entity since they are in the best position to determine the existence of conditions and validate the urgency of the situation.

The BAC may, thus, recommend the use of the alternative method of negotiated procurement after ascertaining that said method is justified pursuant to Section 53 (b) above, subject to the approval of the head of the procuring entity.² No approval from the Government Procurement Policy Board is required unless said resort involves a contract amounting to at least Five Hundred Million Pesos (P500,000,000).³




