Re: Signing of Bids and Awards Committee Resolution

Dear Sir:

In letter dated 3 September 2007, you requested for clarification on the following issues:

- 1. Whether a member of the Bids and Awards Committee (BAC) can still be granted honoraria notwithstanding the fact that its representative is the one who attended the meetings for the entire duration of the procurement process; and,
- 2. Whether a BAC member can sign a resolution decided and passed during a meeting even though he/she is absent.

On the first query, we would like to inform you that under Section 15 of Republic Act No. 9184 and its Implementing Rules and Regulations Part A, it is the Department of Budget and Management (DBM) who is tasked to promulgate the guidelines for the grant/payment of honoraria to the BAC members. Pursuant to this, DBM issued National Budget Circular (NBC) No. 2004-5A, dated 7 October 2005, entitled "Guidelines on the Grant of Honoraria to Government Personnel Involved in Government Procurement", as amended by NBC No. 2007-3, dated 29 November 2007. Considering that DBM is the rightful authority to interpret the aforementioned guidelines, this office deems it wise to defer issuing any opinion on the matter and indorse said concern to Director Myrna S. Chua, Director IV of the Organization Position Classification and Compensation Bureau of the DBM.

With regard to your second query, this office is of the view that any member of the BAC who is not present in any of its meetings should not sign any resolution arising therefrom. Section 12.3 of the Implementing Rules and Regulations Part A (IRR-A) of Republic Act No. (R.A.) 9184 states that a quorum is required in order for the BAC to

transact business. Hence, if a BAC member is absent, he/she is not considered part of the quorum nor involved in any business transacted during the meeting. Thus, any decision concluded by the BAC and reflected in its resolution should only be signed by those members who were present in the meeting.
