Re: Negotiated Procurement under Section 53 (h)

Dear Dir. Laceras:

In letter dated 19 December 2008, the Organization, Position, Classification and Compensation Bureau of the Department of Budget and Management referred to this office your request for clarification, embodied in Memorandum dated 12 December 2008, on whether procurement through Negotiated Procurement under Section 53 (h) of the Implementing Rules and Regulations Part A (IRR-A) of Republic Act No. 9184 (R.A. 9184) entails competitive bidding activities.

Negotiated Procurement under Section 53 (h) of IRR-A does not involve any bidding activity. Under Section 53 (h) of the IRR-A, procuring entities are allowed to resort to the alternative method of negotiated procurement where the amount involved is Fifty Thousand Pesos (P50,000) or less. Consequently, the procuring entity shall simply draw up a list of at least three (3) suppliers, contractors or consultants of known qualifications which will be invited to submit proposals, in case of goods and infrastructure projects, or curriculum vitae, in case of consulting services.<sup>1</sup>

Under Section 5 (e) of R.A. 9184, competitive bidding consists of the following processes: advertisement, pre-bid conference, eligibility screening of prospective bidders, receipt and opening of bids, evaluation of bids, post-qualification, and award of contract.<sup>2</sup>



: Honoraria to Government Personnel Involved in Government

Procurement

- 1.0 This is to respectfully request for clarification on the grant of honoraria to government personnel involved in government procurement, specifically, on Section 5.2 of Budget Circular (BC) No. 2004-5A dated October 7, 2005 listing mode of procurement wherein competitive bidding activities are present, if Negotiated Procurement under Section 53 (h) of the IRR-A of RA 9184 qualifies under procurement that involves competitive bidding.
- 2.0 This office is of the opinion that procurement under Section 53 (h) of the IRR-A of RA 9184 involves competitive bidding as explained hereunder:

BC No. 2004-5A dated October 7, 2005 lists mode of procurement wherein competitive bidding is present. The list include Negotiated procurement under Section 53 (b) of the IRR-A following procedures under Section 54.2 (b), whereby the procuring entity shall draw up a list of at least 3 suppliers or contractors which will be invited to submit bids.

In January 20, 2006, the GPPB in its Resolution No. 004-2006 has amended Section 53 to include item (h) which states thus:

"h) Where the amount involved is Fifty Thousand Pesos (P50,000.00) and below; Provided, however, that the procurement does not result to splitting of contracts, as provided under Section 54.1 of this IRR-A: Provided, further, that the procurement does not fall under Shopping in Section 52 of this IRR-A ... "

As farther provided in Section 54.2 (i) which states "With respect to item (h) of Section 53 of this IRR-A, the procuring entity shall draw up a list of at least three (3) suppliers, contractors or consultants of known qualifications which will be invited to submit proposals, in case of goods and infrastructure projects, or curriculum vitae, in case of consulting services."

Considering that the processes involved in Section 53(b), which is identified as mode of procurement that involves competitive bidding is congruent to Section 53(h), we believe that competitive bidding is likewise present in this method of procurement, hence, successfully completed procurement projects under this method qualifies payment of honoraria to the government personnel involved in the procurement.

- 3.0 May we thus, ask for confirmation if successfully completed procurement projects under Section 53 (h) of the IRR-A entitle the personnel involved in the procurement to honoraria.
- 4.0 We would appreciate receiving reply at the earliest possible time.
