#13 of Technical Specification     Software: Can we offer pre- installed windows 11 Pro, with activated and updated windows defender?	No. 13 of Item A under Section VII. Technical Specifications shall be read as follows:  13. Software: LICENSED Genuine Pre-installed Windows 11 Pro, 64-bit with activated and updated Windows Defender, proof of license shall be submitted to GPPB-TSO upon delivery.
3. Is Eco Label the only requirement?	No. 14 of Item A under Section VII. Technical Specifications provides that computers shall be with Eco Labels <u>such as but not limited to</u> Energy Star, EPEAT, TCO, 80 Plus, and CEC Environmental Protection. Thus, any Eco label will do as long as the copy or proof or the evidence of such certification shall be submitted as part of the bid proposal.
May we clarify what do you mean by plastic cover for computer and keyboard?	No. 14 of Item A under Section VII. Technical Specifications shall be read as follows:  14. Accessories: Plastic fabric dust cover for computer while silicon dustproof and waterproof

6. Under Technical Requirement UPS #3, May we clarify if you require IEC or Universal Socket?	No. 3 of Item B under Section VII. Technical Specifications shall be read as follows:  3. No. of Universal Socket: At least 4
7. Would you consider Certificate of reseller?	Certificate of Reseller is acceptable as long as issued by the Original Equipment Manufacturer.
8. May we clarify if the supplier needs to have a website, or you mean the website of the offered brand?	The Supplier shall have a website for its parts and components where the part numbers and description can be viewed easily by the End-User.  A direct link in the Supplier's website to the Manufacturer's website for this purpose will be
	considered.
9. How many copies of bid is required?	Three (3) – 1 marked as "Original" and 2 marked as "Copy No. 1 and Copy No. 2"
10. May we clarify if you will accept the latest intel 13 <sup>th</sup> Gen	Latest version of Intel Core i7 or its equivalent as of the date of the deadline of submission of bids.
