“PROCUREMENT OF SECURITY SERVICE FOR THE GPPB-TSO NEW BUILDING”

THIS AGREEMENT made the _____ day of AUG 30 2023 2023 between Government Procurement Policy Board – Technical Support Office (GPPB-TSO) of the Philippines (hereinafter called “the Entity”) of the one part and DBPSC Security Service Incorporated of Makati City, Philippines (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Security Service for the GPPB-TSO New Building** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Million One Hundred Ninety-Two Thousand Three Hundred Sixty-Three Pesos and Sixty Centavos (Php4,192,363.60)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - ii. Schedule of Requirements;
 - iii. Technical Specifications;
 - iv. General Conditions of Contract
 - v. Special Conditions of Contract;
 - vi. Performance Security;
 - vii. Notice of Award of Contract and the Bidder’s conforme thereto; and
 - viii. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Supplier agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed and Warranty Security, shall likewise form part of the Contract.
