

Contract Agreement

“SUPPLY, DELIVERY, AND INSTALLATION OF PRIVATE AUTOMATIC BRANCH EXCHANGE (PABX) SYSTEM”

THIS AGREEMENT made the _____ day of SEP 07 2023 2023 between Government Procurement Policy Board – Technical Support Office (GPPB-TSO) of the Philippines (hereinafter called “the Entity”) of the one part and Pronet Systems Integrated Network Solution Inc. of Quezon City, Philippines (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply, Delivery, and Installation of Private Automatic Branch Exchange (PABX)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Million Six Hundred Ninety-Six Thousand Seventy-Five Pesos and Seventy-One Centavos (PhP2,696,075.71)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - ii. Schedule of Requirements;
 - iii. Technical Specifications;
 - iv. General Conditions of Contract
 - v. Special Conditions of Contract;
 - vi. Performance Security;
 - vii. Notice of Award of Contract and the Bidder’s conforme thereto; and
 - viii. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Supplier agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed and Warranty Security, shall likewise form part of the Contract.**

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




