INVITATION FOR NEGOTIATED PROCUREMENT FOR TWO-FAILED BIDDINGS

Procurement of Petroleum Fuel, Oil and Lubricant (POL) Products for the GPPB-TSO

- 1. The Government Procurement Policy Board Technical Support Office (GPPB-TSO) intends to procure Petroleum Fuel, Oil, and Lubricant (POL) Products for the GPPB-TSO with an Approved Budget for the Contract (ABC) of One Million Four Hundred Thousand Pesos (Php1,400,000.00).
- 2. The GPPB-TSO Bids and Award Committee (BAC) now invites technically, legally, and financially capable suppliers for the said project.
- 3. The Procurement procedure for this requirement is Negotiated Procurement for Two-Failed Bidding pursuant to Section 53.1 of 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - The selection of the successful offer shall be based on the best and final offer that will be submitted on the set deadline to the BAC and which would meet the minimum technical specifications required.
- 4. The interested bidders may obtain further information from the BAC Secretariat at the address given below from 19 January 2024 to 26 January 2024, Monday to Friday, 7:00 AM to 4:00 PM.
- 5. The GPPB-TSO will hold the Negotiation Meeting on 24 January 2024 at 9:00 AM via Zoom Videoconferencing through this link: https://zoom.us/j/91278014859?pwd=cHQrTGZKUWlRWGtkU0F5aHI4K2Jjdz09
- 6. Two (2) copies of the proposals (one original and one copy) must be submitted to the BAC which must be duly received by the BAC Secretariat through manual submission at Unit 2506, 25th Floor, Raffles Corporate Center, Emerald Avenue, Ortigas Center, Pasig City on or before 9:00 AM of 26 January 2024. Late submission shall not be accepted.
- 7. Interested bidders shall submit the following documents in sealed envelopes, labeled as "Negotiated Procurement for Two-Failed Biddings", with the title of the procurement project, name of the bidder, address, the contact details of the bidder, addressed to the BAC.

 - In case of Joint Venture, Special Power of Attorney shall be submitted by all members of the joint venture giving full power and authority to its officer to sign the OSS and do acts to represent the Bidder.
