

CONTRACT RENEWAL AGREEMENT

THIS AGREEMENT made the _____ day of _____ 20____ between:

Government Procurement Policy Board – Technical Support Office (GPPB-TSO), an office established to provide support in the performance of the duties and responsibilities of the GPPB, an inter-agency body created by virtue of RA No. 9184, with office address at Commonwealth Avenue, UP Diliman Campus, Quezon City, (hereinafter called “the Entity”), represented by its Chief Administrative Officer, **JULIE D. ABRIGO**,

and

Alert Security Investigation Agency Inc. a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 2447 Belarmino Street Corner Apolinario Street, Brgy. Bangkal of Makati City, Metro Manila (hereinafter called “the Supplier”) represented herein by **MARISSA O. DASIG**;

WITNESSETH THAT

WHEREAS the parties (the Entity and the Supplier) entered into a Contract Agreement for goods and ancillary services, particularly on the **Procurement of Security Services for the Government Procurement Policy Board-Technical Support Office** which is set to expire on 31 January 2025.

WHEREAS, the end-user requested for the renewal of the aforesaid contract (**Procurement of Security Services for the Government Procurement Policy Board - Technical Support Office**) to the GPPB-TSO Bids and Awards Committee (BAC) and submitted the cost benefit analysis and performance evaluation of the Supplier showing a “very satisfactory” rating, in accordance with the Guidelines on Renewal of Regular and Recurring Services under Appendix 37 of the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184.¹

WHEREAS, after determining compliance with the conditions set forth in the aforesaid Guidelines as well as the eligibility of the Supplier, the GPPB-TSO BAC recommended to the Head of the Procuring Entity the renewal of the subject contract agreement in the amount of **Nine Million Two Hundred Fifty-Seven Thousand Six Hundred Three Pesos and Seventy-Nine Centavos (Php9,257,603.79)** (hereinafter called “the Contract Price”).

NOW THEREFORE, for and in consideration of the foregoing, parties hereby agree as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

¹ As this service is covered by Regular and Recurring Services, the renewal followed Appendix 37 Guidelines on Renewal of Regular and Recurring Services of the 2016 Revised IRR of RA 9184: For the Renewal of Contract parties undertake to comply with the following:

- a. The original contract covering the Regular and Recurring Services was awarded in accordance with Republic Act No. 9184 (RA No. 9184) and its 2016 revised Implementing Rules and Regulations (IRR), and other associated issuances;
- b. A Cost-Benefit Analysis (CBA) undertaken by the End-User to show the comparative advantage of renewal over the conduct of another procurement;
- c. A performance evaluation conducted by the End-User showing Satisfactory performance by the service provider
- d. The duration of renewal contract shall not exceed one (1) year; however, the total combined period covering the original contract, renewal contract/s and contract extension/s, if applicable, shall not exceed three (3) years
- e. The service provider must not be a Blacklisted Entity at the time of the conduct of the performance evaluation until the signing of the renewal contract; and
- f. Funds are available for the renewal of contracts in accordance with existing budgeting, accounting and auditing rules.

2. The following documents shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
- i. Contract Agreement Form No. CA-AD-2024-004;
 - ii. Updated Eligibility Documents of the Supplier;
 - iii. Performance Security;
 - iv. Notice of Renewal; and
 - v. Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Nine Million Two Hundred Fifty-Seven Thousand Six Hundred Three Pesos and Seventy-Nine Centavos (PhP9,257,603.79)** or such other sums as may be ascertained,² **Alert Security Investigation Agency Inc.** agrees to **Procurement of Security Services for the Government Procurement Policy Board - Technical Support Office** in accordance with the Notice of Renewal.
4. The **GPPB-TSO** agrees to pay the above-mentioned sum in accordance with the terms of the Notice of Renewal.
